ENGINE LIGHT CAME ON APPROXIMATELY 6/30/97 AND AGAIN 4 WKS AGO DEALERSHIP CHECKED,STATED NO PROBLEM. ENGINE LIGHT CAME ON 5/22/01 AND ON 5/27/01 CAR DID NOT START. PER PEP BOYS ENGINE VALVES BURNED OUT. AIRBAG LIGHT CAME RT AFTER LEFT DEALERSHIP AFTER HAVING THE ELECTRICAL SYSTEM SERVICED BECAUSE DASHBOARD PANEL WENT BLACK AND INTERFERENCE WITH ALARM OPERATION. RETURNED TO DEALERSHIP AND ADVISED AIRBAG LIGHT CAME ON WAS NOT ON PRIOR TO VISIT. THEY CHECK AND ADVISED COMPUTER CHIP WAS BAD AND COST \$800 TO REPLACE. REFUSED RESPONSIBILITY. I TOOK THE CAR IN 11/2000 FOR OVER \$800 IN REPAIRS, INCL 90,000 MILE MAINTENANCE WORK EVEN THOUGH CAR ONLY HAD 84000 MILES. WORK INCLUDED RT CV JOINT REPLACEMENT. WITHIN 2 HOURS RT TIRE WAS FLAT.
