I HAVE ALSO READ LETTERS IN YOUR DATABASE FROM OTHER PONTIAC OWNERS WITH THE SAME PROBLEM OF THE STARTER MOTOR FAILING TO ENGAGE AND THE IGNITION SWITCH BEGINS TO SMOKE.*AK
