I WOULD GUESS THAT IT AEROSOLIZES THE BACTERIA AND OR FUNGI AND SPRAYS THEM AT HIGH SPEED THROUGH THE VENTILATING SYSTEM OUTLETS. I DO NOT KNOW BUT WONDER WHAT POTENTIAL HEALTH RISK THIS POSES TO CHILDREN, PREGNANT WOMEN AND IMMUNOSUPPRESSED PEOPLE OR OTHERS WITH CHRONIC RESPIRATORY ILLNESS SUCH AS ASTHMA AND COPD.
