I'M REPLACING MY TIRES TOMMORROW(05/31/01 AND THEY WON'T BE FIRESTONE!). I STRONGLY URGE ANYONE WITH A FORD SUPER-DUTY AND FIRESTONE STEELTEX TIRES TO REPLACE THE TIRES IMMEDIATELY. I'M REPLACING MY TIRES TOMMORROW(05/31/01 AND THEY WON'T BE FIRESTONE!). I STRONGLY URGE ANYONE WITH A FORD SUPER-DUTY AND FIRESTONE STEELTEX TIRES TO REPLACE THE TIRES IMMEDIATELY.
