DODGE HAS USED PLASTIC GAS LINES IN THE RAM TRUCK. A GROUND HOG NIPPED A GASLINE AND AN ELECTRICAL WIRE LOCATED NEAR THE GASLINE. WHEN THE TRUCK WAS STARTED, THE ENGINE BURST INTO FLAMES. THE FIRE DEPT HAD TO PUT OUT THE FIRE AND THE TRUCK WAS TOTALLED. PLASTIC GAS LINES SHOULD NOT BE PERMITTED IN VEHICLES. ANY RODENT OR ROAD DEBRIS CAN PUNCTURE A GAS LINE CAUSING A DANGEROUS SITUATION.
