WHEN I ENTERED MY VEHICLE AND STARTED IT I ATTEMPTED TO PLACE THE TRANSMISSION INTO DRIVE. THE SELECTOR LEVER JUST HUNTED BUT COULD NOT FIND THE PROPER GEAR. I HAD MY VEHICLE TOWED TO MY TRANSMISSION REPAIR SHOP: JIM JENNINGS TRANSMISSIONS, 601 EASTERN BLVD., ESSEX, MD, 21221, 410-686-6700. THEY INFORMED ME THAT A RETAINER BOLT HAD FALLEN FROM BENEATH THE DASH THAT SUPPORTED THE TRANSMISSION SELECTOR CABLE HOUSING. THEY ALSO STATED THAT THIS HAD BECOME A COMMON PROBLEM WITH THIS TYPE OF VEHICLE. THE FIX WAS TO REPLACE IT WITH THREAD LOCKER.\*AK
