OUR PROBLEM IS WITH THE NEONS HEADGASKET LEAKING. AS MANY NEON ARE OWNED WHY DOESN'T DODGE DO SOMETHING ABOUT THESE CARS LEAKING. I RUN A GARAGE AND WE HAVE DONE ABOUT 25 HEAD GASKET JOBS ON THESE CARS. THIS IS CRAZY! THESE CARS HAVE LOW MILEAGE FOR A CAR BUT ARE OUT OF WARRANTY. I KNOW THAT DODGE REDESIGNED THESE GASKETS. BUT WHY DON'T THEY RECALL THEM. IT IS CRAZY TO HAVE A CAR WITH LESS THAN 40,000 MILES ON IT & HAVE TO REPLACE THE HEAD GASKET. THESE SAME CARS ARE THE SAME AS THE TALONS, ECLIPSES, AND OTHER WITH THE SAME ENGINE PROBLEMS JUST DIFFERENT NAMES. PROBLEM WITH THE LIFTERS ALSO. DODGE HAS REMADE LIFTERS BECAUSE SO MANY PROBLEMS WITH THE OLD DESIGN. TAKE A CAR WITH LESS THAN 50,000 ON IT & IT NEEDS A VALVES REPLACED. OLD VALVES WILL NOT CLOSE PROPERLY. JUST WE
