AFTER SEEING HUNDREDS OF SIMILAR TRANSMISSION PROBLEMS FOR THIS PARTICULAR YEAR OF CARAVANS, I AM FURIOUS. THERE HAS GOT TO BE A DEFECT IN THE TRANSMISSIONS OF THESE VEHICLES. IS THERE ANY HELP OUT THERE?*AK
