ABS SYSTEM CONTINUOUSLY LEAKS BRAKE FLUID ALL OVER THE ENGINE COMPARTMENT. REQUIRES RE-FILLING EVERY MONTH OR SO. ABS RESERVOIR HAS BEEN REPLACED BY DEALER BUT IT STILL LEAKS. ON SEVERAL OCCASIONS THE ABS HAS FAILED TO WORK BECAUSE THE SYSTEM HAD LEAKED ALL ITS BRAKE FLUID AND NEARLY RESULTED IN SEVERAL ACCIDENTS. COMPLAINTS TO THE BBB OF WASHINGTON DC HAVE GONE UNANSWERED REGARDING THIS PROBLEM. *AK
