THE AUTOMATIC TRANSMISSION ON THIS VEHICLE INTERMITTENTLY EMITS A LOUD "CLUNK" (WHICH CAN BE FELT) WHEN SHIFTING BETWEEN GEARS. THE DEALERSHIP HAS TRIED VARIOUS FIXES, INCLUDING REPLACING THE "MEMORY MODULE," YET THE PROBLEM PERSISTS. THEY NOW DENY THAT THERE IS A PROBLEM, AND CLAIM THAT THEIR "EXTENSIVE" TRANSMISSION TESTS REPORT THAT THE TRANSMISSION IS OPERATING WITHIN "NORMAL PARAMETERS" EVEN THOUGH THE SERVICE MANAGER TOLD ME HE COULD ADJUST THE TRANSMISSION SOME MORE. HE HAS SINCE DENIED MAKING THIS STATEMENT, AFTER CHRYSLER'S HEAD OFFICE WAS BROUGHT IN TO THE EQUATION. AS WELL, CHRYSLER'S REGIONAL REPRESENTATIVE TOLD ME THAT THEY WOULD REPURCHASE THE VEHICLE IF THERE WAS STILL ANYTHING WRONG WITH THE TRANSMISSION, YET HAVE ALSO RETRACTED
