THIS IS AN ACKNOWLEDGED PROBLEM FROM BMW. THE MANUFACTURER HAS CLAIMED THAT THE PROBLEM IS NOT BIG ENOUGH TO WARRANT A RECALL. UNFORTUNATELY MANY OF US ARE BEING LEFT STRANDED WHEN THE PROBLEM SURFACES. EVEN THOUGH THE PROBLEM IS ACKNOWLEDGED BMW DOES NOT HAVE THE PARTS REQUIRED TO FIX THE PROBLEM. I BELIEVE BMW NEEDS TO BE CONTACTED AND FORCED TO OFFICIALLY ISSUE A RECALL ON THE 3.0 LITER ENGINES. \*AK
