WE DO NOT BELIEVE THAT THE POWER TRAIN AUTOMATIC TRANSMISSION SHOULD HAVE FAILED AT 58788 MILES. THE VEHICLE IS NOT USED FOR OFF ROAD, HEAVY HAULING, OR FOR ANY OTHER PURPOSE THAN NORMAL CITY/HIGHWAY DRIVING. WE PAID \$1987.74 FOR A NEW AUTOMATIC TRANSMISSION AND WANT TO KNOW IF OTHER CHEVROLET S10 BLAZER OWNERS HAVE HAD SIMILAR PROBLEMS AT LOW MILEAGE. WE WOULD ALSO LIKE TO KNOW IF ANY FACTORY/DEALER RECALLS WERE OUT THERE THAT AS AN OWNER WE WERE NOT NOTIFIED. WE HAVE LEARNED THAT OTHER S10 BLAZER OWNERS HAVE EXPERIENCED AUTO TRANSMISSION FAILURE BUT HAVE NO SPECIFICS ON MILEAGE OR CIRCUMSTANCES SURROUNDING FAILURE. PLEASE REPLY AT EARLIEST OPPORTUNITY.
