THIS IS THE SECOND FORD F-150 THAT WE HAVE IN WHICH THE ALTERNATOR HAS CAUGHT ON FIRE IN THE LAST TWO WEEKS. THE OTHER ONE WAS A 1991 FORD F-150. VIN 1FTDF1545MNA75886. THE 1992 F-150 CAUGHT FIRE IN A PARKING LOT AND BURNED UP THE WIRING HARNESS ALONG WITH HOSES, ALTERNATOR, ETC. THE TRUCK IS PROBABLY A TOTAL LOSS. THE OTHER ONE CAUGHT FIRE WHILE TRAVELING DOWN THE HIGHWAY. WE WERE ABLE TO PUT THIS ONE OUT BEFORE MAJOR DAMAGED OCCURED. I AM VERY DISTRESSED TO HAVE HAD TWO TRUCKS CATCH FIRE IN TWO WEEKS AND FORD MOTOR COMPANY WILL ONLY TRANSFER ME FROM DEPARTMENT TO DEPARTMENT. ANY HELP WOULD BE APPRECIATED. *AK
