BMW WITH M60B30 AND M60B40 V'S FROM 93-95 ENGINES HAVE BEEN KNOWN TO SUFFER DAMAGE TO THE CYLINDER BORES FROM EXCESSIVE AMOUNTS OF SULPHUR IN US FUELS. THE BLOCKS WERE MADE OF NIKASIL. THE PROBLEM REPRESENTS ITSELF AS AN EXCESSIVELY HIGH IDLE WHICH MY CAR HAS. BMW INITIATED AN ENGINE WARRANTY, COVERING ALL INTERNAL LUBRICATED PARTS, WHICH INCLUDES THE SHORT BLOCK FOR 100,000, OR 6 YEARS. I TOOK MY CAR TO BE CHECKED AND THIS IS WHEN I DISCOVERED(BASED ON A COMPRESSION TEST) IT HAS THE PROBLEM BMW KNEW ABOUT. THE PROBLEM IS MY CAR IS MORE THAN 6 YEARS OLD WITH LESS THAN 100,000.00 MILES BMW WILL NOT REPAIR MY PROBLEM ALLTHOUGH THEY ACKNOWLEDGE IT EXISTS.
