THEY DID NOT SEEM INTERESTED THAT THE SAFETY PROBLEM IDENTIFIED IN NHTSA COMPAIN NUMBER 98V234000 MAY BE AFFECTING MORE VEHICLES THAN ORIGINALLY THOUGHT.AK
