THE PROBLEM OF FAILED HEATER HOSE CLAMPS ON THE 6.8 L ENGINE WAS WELL KNOWN TO THE FORD AGENCY WHICH REPAIRED IT UNDER WARRANTY. THE PROBLEM HAS ALSO BEEN DISCUSSED IN THE TECHNICAL COLUMNS OF RV MAGAZINES. THE FAILED CLAMP WAS REPLACED BY ONE OF SIMILAR DESIGN AND OTHERS REMAIN ON THE ENGINE. OBVIOUS DANGEROUS SITUATIONS CAN ARISE WITH FAILED HOSE CLAMPS.
