THE FRONT, DRIVER SIDE CALIPERS DO NOT RELEASE WHICH OVERHEAT THE WHEEL. ON TWO OCCASIONS THE BRAKE PADS HAVE SHEARED OFF, AND WHEN THE TIRES ARE REMOVED TO INSPECT, STUDS EASILY BRAKE OFF. SEARS AUTO CENTER BROKE OFF TWO STUDS AFTER THE 1ST INCIDENT, AND I BROKE OFF ONE STUD AFTER THE 2ND INCIDENT ON JUNE 15, 2001. THE NEGHERBON SERVICE DEPT HAD REPLACED THE CALIPER KIT (SPRINGS AND TRACKS) ON 3/13/01. THE WHEEL GETS SO HOT THAT YOU BURN YOUR FINGER IF YOU TOUCH IT. THIS PROBLEM DOES NOT HAPPEN EVERY TIME. THE OVERHEATING HAPPENS DURING TIMES WHEN THE BRAKES ARE USED OFTEN (BENICIA IS VERY HILLY), AND DOES NOT HAPPEN DURING HIGHWAY RIDES, WHEN THERE IS NO TRAFFIC. MY CONCERN IS THAT WHEN THE BRAKES STARTS TO HEAT UP DO TO USE, THE CALIPER DOES NOT RELEASE AS FREELY, AND
