SOMETHING IS WRONG WITH THE BRAKE SYSTEM IN THIS JEEP - I BEEN ADVISED THAT SOME 1999 JEEPS WERE RECALLED FOR THE SAME PROBLEM BUT NOT MINE--HELP PLEASE THANKING YOU IN ADVANCE ORIGINAL ROTOR AND PADS FAILED AT 9,564 MI AND THE DEALER REPLACED THE PARTS AT NO COST. *AK
