WHILE DRIVING ON A WELL MARKED AND WELL USED DIRT/ROCK BACKROAD AT 10-20 MPH, THE LEFT REAR TIRE SUDDENLY FAILED CATASTROPHICALLY. THE TREAD SEPARATED FROM THE SIDEWALLS AND THE INNER SIDEWALL WRAPPED ITSELF AROUND THE AXEL SEVERING THE FLEXIBLE RUBBER HYDRAULIC BRAKE HOSE.
