NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

UPON SEPARATION OF THE LEFT FRONT FLEXIBLE BRAKE LINE, A COMPLETE AND INSTANTANEOUS BRAKE FAILURE OCCURRED. THE SECONDARY BRAKE SYSTEM (REAR ABS DRUM BRAKES) WAS INEFFECTIVE EVEN THOUGH THE REAR HALF OF THE BRAKE MASTER CYLINDER RESERVOIR WAS PROPERLY SERVICED. NO BRAKE WARNING LIGHT HAD ILLUMINATED PRIOR TO THE PRIMARY BRAKE FAILURE TO INDICATE ANY PROBLEM EXISTED WITH THE SECONDARY (REAR) BRAKES. HOW CAN A MODERN DUAL BRAKE SYSTEM FAIL COMPLETELY WITH NO PRIOR INDICATION OF PROBLEMS. THE DEALER REPLACED THE FLEXIBLE BRAKE LINE AND STATED "IT WORKS FINE" BUT NO BRAKE WARNING SYSTEM COMPONENTS OR REAR BRAKE COMPONENTS WERE REPLACED. AK
