DEALER HAS INDICATED THAT LEFT SIDE IS ALSO LIKELY TO FAIL AND THAT ANY REPAIR DOES NOT GUARANTEE A RECURENT FUTURE FAILURE. VW CORPORATION HAS REFUSED FINANCIAL ASSISTANCE IN REPAIRING PROBLEM. NHTSA LISTS NUMEROUS CUSTOMER COMPLAINTS FOR THIS SAME PROBLEM. CUSTOMERS POSITION IS THAT A PART AS BASIC AS THIS SHOULD NEVER FAIL AND THIS REPRESENTS A FAULTY ORIGINAL DESIGN.
