I HAD TO HAVE THE BALANCER SHAFT SEALS REPLACED ON MY 96 ACCORD AFTER THEIR COMPLETE FAILURE AT A COST OF \$700. IN OCTOBER I RECEIVED WORD THAT THE CAR WAS BEING RECALLED FOR THE PROBLEM AND THAT I COULD SUBMIT FOR REIMBURSEMENT. WAS TOLD TO EXPECT PAYMENT IN 8 WEEKS. THAT WAS 8 MONTHS AGO. HONDA IS NOT PROCESSING THESE REIMBURSEMENTS IN EVEN A REMOTELY TIMELY MANNER. THEY CLAIM THEY UNDERESTIMATED THE TIME INVOLVED, BUT EVEN IF THEY PROCESS 5 A DAY THEY SHOULD BE MAILING OUT CHECKS. THEY ARE STONEWALLING, AND REFUSE TO COMMUNICATE WITH THE CONSUMER OVER THE MATTER.*AK
