NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I WAS DRIVING THE VEHICLE WHEN IT BEGAN TO ACCELERATE UNCONTROLLABLY. IT CONTINUED TO ACCELERATE WITH MY FOOT COMPLETELY REMOVED FROM THE ACCELERATOR. AT THE TIME THIS WAS HAPPENING I WAS IN SOME TRAFFIC AND BY BRAKING HEAVILY TO SLOW THE VEHICLE I WAS ABLE TO SLOW IT ENOUGH TO PREVENT BEING INVOLVED IN ANY KIND OF INCIDENT. I THEN PULLED OFF OF THE ROAD AND DEPRESSED THE CLUTCH. WITH THE CLUTCH DEPRESSED THE TRUCKS ACCELERATOR CONTINUED TO ACCELERATE UNCONTROLLABLY TOWARDS THE REDLINE SO I SHUT THE ENGINE OFF. I THEN RESTARTED THE ENGINE AND IT SEEMED TO HAVE BECOME UNSTUCK. I WAS ONLY ABOUT A QUARTER OF A MILE FROM A MECHANIC'S SHOP THAT I WAS FAMILIAR WITH AND TRIED TO GET THERE. AS I ACCELERATED THROUGH THE GEARS THE THROTTLE AGAIN BECAME STUCK AND BEGAN TO ACCE
