VEHICLE HAS HAD CONSISTENT BRAKE LEAD AND PULL TO RIGHT AND LEFT, EXCESSIVE BRAKE PAD WEAR AND WARPAGE OF BOTH ROTORS WHICH CAUSES A SHIMMY, WOBBLING AND SHAKING OF STEERING. THIS VEHICLE IS DRIVEN MAINLY ON OPEN ROADS AND HIGHWAYS, RARELY IN TRAFFIC. ON MANY OCCASIONS WHEN BRAKING THE VEHICLE WILL PULL HARD OVER TO THE LEFT, SOMETIMES RIGHT, ESPECIALLY ON OFF RAMPS, OFTEN TIMES NEEDING A STRONG CORRECTION TO KEEP VEHICLE FROM LEAVING THE ROADWAY. VEHICLE HAS BEEN TO DEALER 5 TIMES FOR TESTING AND REPAIR. HOWEVER IT WAS NOT THE DEALER WHERE TRUCK WAS PURCHASED. *AK
