C220 WAS PROCEEDING NORTH WHEN STRUCK IN THE CENTER FRONT AND DRIVER SIDE FRONT BY A SECOND VEHICLE MOVING SOUTH. SECOND VEHICLE WAS PROCEEDING EAST WHEN STRUCK BY THIRD VEHICLE WHICH PROPELLED SECOND VEHICLE INTO C220. ESTIMATED SPEEDS OF OTHER VEHICLES WERE: 2ND = 40 MPH AND 3RD = 50 MPH. IN THE C220 THE DRIVER AIRBAG DID NOT DEPLOY AND THE PASSENGER AIRBAG DID DEPLOY. THE AIRBAGS ON THE OTHER VEHICLES DEPLOYED. IS THE AIRBAG DEPLOYMENT FOR THE C220 CORRECT? *AK
