SEVERAL TIMES PRIOR TO COMPLETE POWER FAILURE, VEHICLE DECELERATED ON ITS OWN WITH A SMALL JAR AS IF TAPPED FROM REAR, THEN @ 45 MPH I LOST COMPLETE POWER, NO STEERING ABILITY, POWER BRAKES GONE, COASTED TO STOP. NO INDICATOR LIGHTS PRIOR TO POWER LOSS, TURNED OFF A/C, RADIO ETC. VEHICLE RE-STARTED. I TOOK TO DEALER NEXT DAY. THEY HAD IT FOR 3 DAYS, & ONLY REPLACED BATTERY. PICKED UP VEHICLE ON 6/28 & 6/30 VEHICLE SHUT DOWN @ 45-50 MPH SAME SCENARIO, TOOK BACK TO DEALER AND THEY REPLACED MODULE-POWERTRAIN CONTROL. PICKED UP 07/03, DROVE LESS THAN 10 MI & VEHICLE STARTED THE DECELERATION PROBLEM AGAIN.\*AK
