NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

OVER A PERIOD OF SEVERAL WEEKS, THE TRANSMISSION BEHAVED ERRATICALLY, OFTEN SHIFTING OUT OF GEAR INTO NEUTRAL OR FROM NEUTRAL INTO DRIVE. THESE SHIFTS WOULD OCCUR WHEN THE ENGINE WAS RUNNING BUT WITH NO ONE TOUCHING THE GEAR SHIFT LEVER. MOST OFTEN, THIS OCCURRED AT STOP SIGNS OR LIGHTS. THEN, ON JUNE 20, THE TRANSMISSION SHIFTED INTO LOW GEAR ON ITS OWN AND REMAINED LOCKED THERE. FORTUNATELY, NO ACCIDENTS OR INJURIES HAVE OCCURRED. HOWEVER, SINCE TAKING THE VEHICLE IN FOR TRANSMISSION REPAIR OR REPLACEMENT, THE DEALER SEEMS UNABLE TO FIX THE VEHICLE AND HAS NOT BEEN ABLE TO RETURN IT TO ME. THIS SUGGESTS A SUBSTANTIAL AND POTENTIALLY INHERENT TRANSMISSION PROBLEM WITH SERIOUS SAFETY IMPLICATIONS.*AK
