MY VEHICLE WAS PARKED IN MY GARAGE (BACKED IN). I STARTED THE VEHICLE AND MOVED FORWARD SEVERAL FEET SO THAT I COULD UNLOAD SOMETHING FROM THE REAR STORAGE AREA. I BELIEVED THAT I HAD SHIFTED INTO "PARK" AND EXITED THE VEHICLE. VEHICLE THEN BEGAN MOVING IN REVERSE, STOPPING WHEN IT STRUCK SOME CABINETS AT THE REAR OF THE GARAGE. REAR LIFTGATE BENT AND CAUSED THE REAR GLASS TO SHATTER.
