THE FAULTY BALL JOINTS/CONTROL ARMS NOT ONLY EFFECT THE HANDLING OF THE VEHICLE BUT ALSO THE WEAR OF THE TIRES AND STRUTS/SHOCKS. THE BALL JOINTS/CONTROL ARMS SHOULD NOT WEAR OUT THIS FAST.*AK
