FORD INITIALLY AGREED TO PAY FOR THE DAMAGES TO THE CAR AND REPLACEMENT OF THE AIRBAG, BUT IS NOW CLAIMING THAT THE AIRBAG IS ONLY COVERED FOR 5 YEARS OR 50,000 MILES. THEY CLAIM THAT THIS IS ONLY COVERED UNDER WARRANTY, EVEN THOUGH IT IS AN OBVIOUSLY DEFECTIVE PART.*AK
