I PURCHASED MY TRUCK BRAND NEW IN NOV. OF 1998 WITH APPROX. 10 MILES ON IT. AFTER ABOUT 6 MONTHS OF OWNERSHIP, WE STARTED HAVING PROBLEMS WITH THE TRUCK QUITTING FOR NO APPARENT REASON. WE HAVE TAKEN THE TRUCK INTO SEVERAL DIFFERENT DEALERSHIPS FOR THE SAME PROBLEM OVER THE PAST 2 YEARS, AND EACH TIME THE VEHICLE WAS SENT HOME WITH US UNFIXED, TELLING US THAT THEY COULD NOT GET THE TRUCK TO DUPLICATE THE PROBLEM. THE PROBLEM WITH THIS IS THAT THE PROBLEM IS INTERMITTENT. IT MAY QUIT TODAY, AND NOT AGAIN FOR 2 MONTHS, OR IT MAY QUIT TODAY AND AGAIN TOMORROW. WE HAVE HAD THE TRUCK IN APPROX. 6-8 TIMES SINCE WE PURCHASED IT BRAND NEW FOR THE SAME PROBLEM, YET UNFIXED EVERY SINGLE TIME. THE TRUCK HAS HAD TO BE TOWED TO A DEALERSHIP 3X AS IT QUIT AND WOULDN'T RESTART. WH
