### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

BOTH REAR BRAKE ROTORS HAD HARD SPOTS ON THE INSIDE WEAR SURFACES, LEADING TO PREMATURE FAILURE OF THE PADS AND POOR BRAKING PERFORMANCE. ROTORS WERE OBVIOUSLY DEFECTIVE AND THE DEALER DID NOT EVEN ATTEMPT TO RESURFACE THE ROTORS. OLDSMOBILE CUSTOMER ASSISTANCE WAS CONTACTED BUT DENIED MY CLAIM THAT THEY WERE DEFECTIVE. BOTH REAR ROTORS HAD THE SAME FAILURE AND APPEARANCE, WHICH INDICATES TO ME THE CASTINGS HAD HARD SPOTS IN THEM WHEN THEY WERE NEW.\*AK
