VAN IN REVERSE BACKING OUT OF MY GARAGE, WE HEARD A LARGE KNOCK FROM THE ENGINE AND THE VAN ROCKED. AT THIS POINT THE VAN LOCKED UP, COULD NOT MOVE IN REVERSE OR DRIVE. THE VEHICLE WAS LOCKED UP TO THE POINT THAT IT COULD NOT BE PUSHED IN NUETRAL, THE TIRES EVEN SKID ON THE DRIVEWAY WHEN BEING PULLED ONTO THE BACK TO THE TOW TRUCK. TRANSMISSION REPAIR (\$1800) REQUIRED. WAS TOLD THAT "PLANETARY" EXPLODED AND DESTROYED TRANSMISSION, A TYPICAL PROBLEM WITH CHRYSLER 3 SPEED TRANSMISSIONS. CALLED CHRYSLER CUSTOMER SERVICE, BUT DENIED ANY HELP DUE TO OVER WARRANTY AND DID NOT PURCHASE AN EXTENDED WARRANTY (THEY JUST WANT MONEY). IT DIDN'T MATTER THAT I HAD TRANSMISSION SERVICE IN JAN. 01 AND EVERYTHING LOOKED FINE. THIS A VERY DANGEROUS PROBLEM, I HAD MY WIFE AND 2 AND 4 YE
