FRONT TIRE ON THIS MOTORCYCLE IS SEVERELY CUPPED. I HAVE CONTACTED THE MANUFACTURER AND RECEIVED NOTHING BUT DOUBLE TALK. THIS TIRE IS THE ORIGINAL EQUIPMENT ON A NEAR-\$20K MOTORCYCLE. TO DATE THERE ARE NO OTHER MANUFACTURERS OF THIS SPECIFIC TIRE SIZE FOR THIS MOTORCYCLE. AT SPEEDS BELOW 30 MPH THE FRONT END SHAKES/WOBBLES CREATING WHAT I FEEL IS AN UNSAFE CONDITION. BOTH HONDA AND BRIDGESTONE/FIRESTONE ARE AWARE OF THE PROBLEM. NEARLY EVERY OWNER OF THIS NEW MOTORCYCLE HAS BEEN AFFECTED BY THIS PROBLEM. THE MANUFACTURER IS TELLING ME TO INFLATE THE TIRES TO A HIGHER PRESSURE THAN MY OWNER'S MANUAL STATES. I DON'T HAVE A PROBLEM WITH THIS EXCEPT FOR THE FACT THAT THE DAMAGE HAS ALREADY BEEN DONE. OVER INFLATION WILL NOT CORRECT THE PROBLEM. I HAVE AN EMAIL RESPONSE

FRONT TIRE ON THIS MOTORCYCLE IS SEVERELY CUPPED. I HAVE CONTACTED THE MANUFACTURER AND RECEIVED NOTHING BUT DOUBLE TALK. THIS TIRE IS THE ORIGINAL EQUIPMENT ON A NEAR-\$20K MOTORCYCLE. TO DATE THERE ARE NO OTHER MANUFACTURERS OF THIS SPECIFIC TIRE SIZE FOR THIS MOTORCYCLE. AT SPEEDS BELOW 30 MPH THE FRONT END SHAKES/WOBBLES CREATING WHAT I FEEL IS AN UNSAFE CONDITION. BOTH HONDA AND BRIDGESTONE/FIRESTONE ARE AWARE OF THE PROBLEM. NEARLY EVERY OWNER OF THIS NEW HONDA MOTORCYCLE HAS BEEN AFFECTED BY THIS PROBLEM. THE MANUFACTURER IS TELLING ME TO INFLATE THE TIRES TO A HIGHER PRESSURE THAN MY OWNER'S MANUAL STATES. I DON'T HAVE A PROBLEM WITH THIS EXCEPT FOR THE FACT THAT THE DAMAGE HAS ALREADY BEEN DONE. OVER INFLATION WILL NOT CORRECT THE PROBLEM. I HAVE AN EMAIL RESPONSE
