I STOPPED MY CAR AT THE BASE OF MY DRIVEWAY AND PUT THE GEAR SHIFT LEVER ON PARK TO CHECK MY MAILBOX. I LEFT THE CAR RUNNING WHILE I DID THAT. AS I GLANCED AT MY MAIL, THE CAR SLOWLY ROLLED UP MY DRIVEWAY (NO ONE WAS IN THE CAR, AND THE GEAR SHIFT LEVER REMAINED IN PARK) AND CRASHED INTO A LARGE TREE ABOUT 40 FEET BEYOND MY DRIVEWAY. WHEN THE TOW TRUCK DRIVER PULLED MY CAR BACK ONTO THE DRIVEWAY, HE SAID THAT THE SHIFT LEVER WAS STILL IN PARK. I SUSPECT THAT MY CAR WAS A "VICTIM" OF NHTSA CAMPAIGN ID NUMBER 94V165000.*AK
