THE POWER STEERING PRESSURE LINE BLEW OUT OF THE PUMP AS WE BACKED OUT OF THE GARAGE. THE PUMP QUICKLY EMPTIED ITS OIL SUPPLY ONTO THE SERPENTINE BELT, ENGINE BAY & THE DRIVEWAY. IT APPEARS AS IF THE RETAINING O-RING WAS SHEARED IN HALF AS THE MALE FITTING BLEW OUT OF THE RETAINING NUT THAT ATTACHES IT TO THE PUMP. I HAVE DIGITAL CLOSE-UP PICTURES OF THE FAILED PART IF DESIRED (E-MAIL). THERE IS NO EXCUSE FOR THIS TOTALLY DISABLING FAILURE IN A 2 YR OLD CAR!!*AK
