ON MONDAY, APRIL 30,2001, I DROVE MY 1999 GMC JIMMY INTO THE DRIVEWAY OF MY HOME. I STOPPED THE CAR WITH MY FOOT BRAKE TO LET MY HUSBAND GET OUT OF THE FRONT PASSENGER SIDE. I PUSHED THE BUTTON TO MAKE THE GARAGE DOOR GO UP SO HE COULD GET IN. HE DIDN'T DUCK FAR ENOUGH AND HIT THE TOP OF HIS HEAD ON THE BOTOM OF THE DOOR. IT STUNNED HIM AND HE SPUN AROUND AND BACK TOWARDS THE CAR AND SLUMPED OVER THE HOOD OF THE CAR (HEAVILY ENOUGH TO MAKE A DENT). I PUT THE CAR IN PARK AND GOT OUT OF THE CAR TO HELP HIM. I PUT MY BACK AGAINST THE CAR AND PUSHED HIM UP. HE SEEMED OK SO I HELPED HIM INTO THE HOUSE. WHEN I WAS SURE HE WAS FINE, I WENT BACK OUT TO PUT THE CAR IN THE GARAGE. IT WAS STILL WHERE I LEFT IT WITH THE MOTOR RUNNING AND THE DOOR OPEN. I PUT MY RIGHT FOOT UP ONTO THE FLOOR OF
