IT WAS REPLACED FOR THE THIRD TIME BY ANOTHER REPAIR SHOP ON 7/16/01. I BELIEVE THIS HIGH RATE OF FAILURE NEEDS TO ADDRESSED BECAUSE OF FAILURE TO HAVE BREAK LIGHTS.*AK
