NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE ANTILOCK BRAKE LIGHT AND BRAKE LIGHTS, BOTH WERE COMING ON AND WOULD EVENTUALLY GO OFF AFTER 30 SECONDS TO A MINUTE. DURING THIS PERIOD, I WOULD FROM TIME TO TIME LOOSE BRAKE CONTROL - BRAKE PEDAL WOULD GET VERY HARD, AND IT WOULD BE DIFFICULT TO STOP. DEALERSHIP REPLACED ANTILOCK BRAKE SYSTEM AS IT HAD BEEN A 1994 RECALLED ITEM, BUT THE LIGHTS CONTINUED TO STAY ON AND I CONTINUED TO HAVE THE SAME PROBLEMS, ALTHOUGH THE DEALERSHIP ASSURED ME THAT THE LIGHTS WOULD GO OFF EVENTUALLY AND THAT THERE WOULD NOT BE ANY PROBLEMS. HOWEVER, WITHIN A WEEK THE LIGHTS DO NOT GO OFF AT ALL AND THE BREAKS ARE LOSING CONTROL MORE FREQUENTLY.*AK
