AIR BAG -- CONTROL MODULE FAILURE AT 67000 MILES. SRS LIGHT ON PANEL INDICATED PROBLEM. DIAGNOSTICS SHOWED CODE 6-2. CAR NEEDS CONTROL UNIT #06772-SX0-A70. COST \$654.00 + TAX. IF OWNER CANNOT AFFORD REPAIR, CAR WILL BE DRIVEN WITHOUT BENEFIT OF AIR BAGS. POWER WINDOW -- DRIVER'S SIDE FRONT, CLICK SOUND WHEN ROLLING UP WINDOW AT 42,000 MILES. WINDOW STOPPED WORKING ENTIRELY AT DEALER'S REPAIR FACILITY. REGULATOR AND MOTOR WERE REPLACED. POWER DOOR LOCKS -- LOCKS WOULD RECYCLE WHEN OWNER ATTEMPTED TO LOCK THE CAR. LEFT FRONT POWER DOOR LATCH AND ACTUATOR REPLACED AT 42,000 MILES. ENGINE -- OWNER DROVE THE CAR 9 MILES TO WORK BEFORE OIL INDICATOR LAMP FINALLY CAME ON WHEN PARKING. SOMETHING IN THE ENGINE FAILED WHEN CAR STARTED, EVIDENCE OF SUDDEN OIL LEAK IN HOME DRIVE
