PURCHASED ENTIRE NEW ASSEMBLY AND REPLACED MYSELF. THIS PAST WEEDEND, THE PASSENGER SIDE LENS HAS FALLEN OFF. RESEARCH INDICATES THIS IS A COMMON PROBLEM. SO COMMON THE DEALERSHIP IS ON A WAITING LIST FOR REPLACEMENT OF THE ASSEMBLY. THIS IS CLEARLY A MANUFACTURER DEFECT.*AK
