OUR CAR SPORADICALLY STALLS WHEN COASTING TO A STOP, CHANGING GEARS FROM DRIVE TO REVERSE, AND WHEN GOING OVER ANY SMALL BUMP IN THE ROAD. WE'VE TAKEN IT TO THE DEALER FOR REPAIR BUT THEY CLAIM THAT THEY'RE NOT ABLE TO REPLICATE THE PROBLEM. IT'S BEEN TO THE DEALER TWICE NOW AND THE STALLING HAS OCCURRED MORE THAN 15 TIMES IN A SPAN OF A MONTH. THE STALLING CAUSES ALL POWERED SYSTEMS TO FAIL (IE. BRAKES, STEERING). *AK
