THIS HAS HAPPENED TWICE NOW AND IT IS APPROXIMATELY A 600.00 REPAIR. IN TALKING TO THE REPAIR DEPT. AT A LOCAL DEALERSHIP, THIS IS A FAIRLY COMMON PROBLEM. THE SAME PROBLEM HAS OCCURRED TWICE TO MY FATHER'S 1997 JEEP WRANGLER ALSO.*AK
