HAVE REPLACED THE BRAKES AND ROTORS THROUGH THE DEALERSHIP 3 TIMES PRIOR TO CURRENT PROBLEM. CALIPER IS NOW FROZE UP WHICH IN TURN WARPED THE ROTOR LESS THEN 24 HRS LATER. HAVE HAD PROBLEMS WITH THE FRONT END ALIGNMENT . REPLACED 4 TIRES DUE TO THIS PROBLEM WHICH IS CURRENTLY CHEWING OFF NEW SET OF TIRES. DEALERSHIP REFUSES TO REPLACE CALIPER OR ROTOR DUE TO EXPIRED WARRANTY ON VEHICLE. FEEL IT IS A PERSISTENT PROBLEM AND SHOULD BE CORRECTED AND FIXED AT EITHER MANUFACTURERS EXPENSE OR DEALERSHIPS EXPENSE. *AK
