VEHICLE ACCELERATES/SURGES, WITHOUT WARNING WHEN IN REVERSE OR AUTOMATIC 1ST GEAR. THIS HAPPENS SPORADICTLY, MAYBE ONCE EVERY 2-3 WEEKS, WITHOUT WARNING. I TOOK IT TO A LOCAL FORD DEALER AND NOTHING SHOWED UP ON THEIR COMPUTER. THEIR MECHANIC WENT ON THE FORD HOTLINE AND FOUND THAT THE PROBLEM WAS LISTED, AND A POSSIBLE FIX SUGGESTED. THE MECHANIC REHOOKED THE VEHICLE BACK UP TO THE COMPUTER AND FOUND THAT THE FIX HAD ALREADY BEEN INSTALLED ON THE TRUCK, AND OBVIOUSLY WAS NOT WORKING. AN APPOLOGETIC SERVICE REP. HANDED ME THE KEYS AND I DROVE HOME IN MY DEFECTIVE TRUCK. THIS PROBLEM IS ALSO LISTING BY OTHER OWNERS ON FORD ESCAPE OWNER WEBSITES.\*AK
