FIRESTONE REFUSED ANY RESPONSIBILITY. AFTER REPLACING THE FRONT TIRES, LEAVING THE ORIGINAL REAR TIRES, 2 MONTHS LATER, LEAVING AN ON RAMP TO I-4 AT APPROXIMATELY 37 MILES AN HOUR, THE REAR RIGHT TIRE TREAD PEELED OFF TOO.
