NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I PURCHASED THIS TRUCK NEW, AND AT APPROXIMATELY 23,000 I WAS DRIVING THE VEHICLE AT AROUND 55MPH WHEN THE ENGINE FAILED. IT DID NOT SPURTER OR KNOCK, IT JUST QUIT, ALL THE GAUGES, ENGINE QUIT INSTANTLY. I PULLED OVER TO THE SIDE OF THE ROAD AND TURNED THE KEY OFF, AND THEN RE-STARTED THE ENGINE. MOTOR STARTED WITHOUT HESITATION, AND I PROCEEDED DOWN THE ROAD. TWO DAYS LATER, WITH LOTS OF DRIVING TIME IN BETWEEN, THE SAME THING HAPPENED. IT DIED, I PULLED OVER, TURNED OF IGNITION, AND RE-STARTED THE MOTOR, AND AGAIN THE MOTOR STARTED WITHOUT HESITATION. ABOUT TWO WEEKS LATER, I WAS DRIVING AT ABOUT THE SAME SPEED AND AGAIN THE SAME THING, EXCEPT THIS TIME THE MOTOR WOULD NOT RE-START. VEHICLE WAS TOWED TO THE DEALERSHIP, AND IT WAS DETERMINED THAT THE FUEL PUMP HAD FAILED
