DOZEN POWER WINDOW REGULATOR AND MOTOR FAILURES SINCE NEW. FIRST ONE AT 4,373 MILES. ABOUT ONCE EVERY SIX MONTHS ON AVERAGE I HAVE TO DEAL WITH THE WINDOW FALLING INTO THE DOOR OR GETTING STUCK UP. I'VE PAID THROUGH THE NOSE TO GET THESE REPAIRED. I'VE TALLIED QUITE A BIT OF SIMILAR AND IDENTICAL INCIDENTS OF THIS PROBLEM, IN OTHER MODELS AS WELL, AND I THINK IT'S ABOUT TIME VW IS FORCED TO DO SOMETHING ABOUT IT. THEY'VE DUPPED THOUSANDS OF OWNERS ON THIS PROBLEM AND THEIR CLAIM THAT THE WARRANTY IS EXPIRED SHOULDN'T BE ACCEPTED ANYMORE, ESPECIALLY IF THE FAILURES OCCURED UNDER WARRANTY AND THEN CONTINUALLY BREAK AFTERWARD. THE NHTSA OUGHT TO HELP ALL THE OWNERS FILE A CLASS ACTION SUIT ON BEHALF OF THE OWNERS TO COMPENSATE THEM FOR THEIR TROUBLES AND FRUSTRAT
