I TOOK MY 1998 DODGE DURANGO INTO ALLEN MELLO DODGE 6/21/01 FOR A WHISTLING NOISE COMING FROM THE FRONT END. THEY DECIDED TO REPLACE THE SERPENTINEBELT. WHEN I PICKED UP THE CAR THE NOISE WAS LOUDER THAN WHEN I DROPPED IT OFF. THEY SUGGESTED THAT I BRING IT BACK 7/10/01 WHEN I HAD AN APPOINTED TO HAVE THE CAT. CONVERTER REPLACED. JUNE 23, 2001 I TOOK A DAY TRIP AND ON THE WAY HOME THE CAR BROKE DOWN. I HAD TO HAVE THE CAR TOWED TO THE NEAREST DEALER WHERE THEY ADVISED ME THAT THE UNIVERSAL JOINT BROKE CAUSING THE DRIVE SHAFT, TRANSFER CASE, SHIFT ROD, ROD GEAR, PIVOT GEAR AND SOME OTHER PARTS TO BE DESTROYED. I ASKED THE MECHANIC IN TILTON NH IS THE UNIVERSAL JOINT MAKES A WHISTLING NOISE AND HE SAID THAT COULD HAVE BEEN A SIGN. I HAVE CALLED CHRYSLER AND ALLEN MELLO DODGE
