WE HAVE CONTACTED CHRYSLER AND HAD THE VEHICLE REPAIRED AT THE DEALER. USAA (OUR INSURANCE) HAS PAID FOR ALL REPAIRS WITH EXCEPTION OF THE \$250 DEDUCTABLE. THE MANUFACTURER IS CLAIMING "NORMAL WEAR AND TEAR". WHAT WOULD THEY BE SAYING IF THERE HAD BEEN A FATALITY, WHICH WOULD HAVE BEEN CERTAIN DURING PEAK TRAFFIC.\*AK
